







After the potting material is cured, the core, wire and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

- The soldering profile has to be complied with according to the technical wave soldering specification, otherwise this will void the warranty.
- Reflow soldering is only allowed after evaluation and approval.
- All products shall be used before the end of the period of 12 months based on the product date code, if not a 100% solderability can't be ensured.
- Violation of the technical product specifications such as exceeding the nominal rated current will void the warranty.
- Due to heavy weight of the component, strong forces and high accelerations might have the effect to damage the electrical connection or
 to harm the circuit board and will void the warranty.
